Your request for information was received on 15th October 2020 and was dealt with under the terms of the Freedom of Information Act 2000. Please be advised that the Business Services Organisation (BSO) has now completed its search for the information you requested with regards to a list of firms and contract values that were involved in the provision of PPE equipment to Northern Ireland since March 2020.

Please find this information attached.

Please note that the attached information identifies the suppliers of PPE to Northern Ireland Health and Social Care (NIHSC) during the period 1 March 2020 until the date of request. The value of contracts awarded is drawn from the value of orders placed during the specified timeframe. It should be noted that not all of these orders have been fulfilled to date.

Please also note that individual NIHSC Organisations may have awarded contracts directly. BSO Procurement and Logistics Service would not hold this information, and if required, it should be obtained by contacting each Organisation directly.

I hope that the information provided assists you. If you are dissatisfied in any way with the handling of your request, you have the right to request a review. You should do this as soon as possible or in any case within two months of the date of issue of this letter.
