## **Prescription Submission to the Business Services Organisation**

Within the 30-day payment cycle contractors are responsible for ensuring, on a twice monthly basis, that prescriptions are submitted securely and timely to be Business Services Organisation (BSO).

As part of the July 2025 prescription submission 39 contractors did not comply with the agreed three-day delivery schedule with 1 contractor delivering too late for their second submission to be processed as part of their August 2025 payment.

If you use a courier to deliver to BSO the timetable below details the dates the submissions must be ready for collection. Please note it is <u>your</u> responsibility to ensure the courier deliveries to BSO are within the three-day delivery schedule noted above:

## **Contractors are reminded that:**

- when delivering directly to the BSO deliveries must be made within the delivery schedule noted above, however, please note we also accept deliveries before these dates;
- when using a courier service your prescription submission must be ready by 9am on the first day of the agreed collection period, noted in the table above. Where your submission has <u>not</u> been collected and/or where there is a risk of a late submission, it is your responsibility to contact the courier or deliver your submission directly to the BSO, 2 Franklin Street, Belfast, BT2 8DQ. To ensure the smooth transfer of prescriptions to the BSO please comply with the courier's requirements e.g. label, sufficient package, etc, further details can be obtained directly from your courier service;
- whilst it is not the responsibility of the BSO we will, where possible, bring late submissions to your attention;
- BSO will not chase up any courier service you choose to use. This contract is between yourself and the courier;
- contractors are reminded to enable BSO to process your payment within 30-days each first submissions must contain a minimum of 60% of total forms for the month and contain prescriptions from <u>ALL</u> batches noted on the HS30 i.e. NOT only fully coded;
- oxygen prescriptions with a completed P01 form should be submitted as part of the second submission;
- By not complying with the dates above you are risking your payment.
