Automatic passporting to Help with Health Costs scheme for Universal Credit claimants to be introduced from 1 December 2025

I am writing to inform you that the *Travelling Expenses and Remission of Charges Regulations (Northern Ireland) 2004* have been amended to ensure that eligible Universal Credit recipients are automatically passported to the Help with Health Costs scheme. These changes, which bring Northern Ireland into line with the rest of the UK, will take effect from **1 December 2025.**

The Department of Health has worked closely with the Department for Communities to implement this legislation and ensure a smooth transition for both patients and providers.

From 1 December, eligible Universal Credit recipients will be automatically passported to the

Help with Health Costs (HwHC) scheme, without the requirement to complete an HC1 form or

undergo assessment.

Eligible recipients are entitled to:

• Free sight tests

Free dental treatment

Reimbursement of travel costs for health and social care treatment

Not all Universal Credit recipients will be automatically eligible for the Help with Heath Costs

scheme. As in Great Britain, an earnings threshold will apply in Northern Ireland to determine

eligibility. Patients who are not automatically passported can still apply under the Low-Income

Scheme to have their eligibility assessed prior to treatment.

The Department for Communities will issue advice to Universal Credit claimants on the

impact of these changes in the coming weeks. Practices should continue to advise patients to

check their entitlement.

To coincide with the 1 December 2025 introduction of passporting and to reflect this new

category of charge exemption, BSO will be issuing updated paper claim forms and amending

online/electronic claiming systems. Further guidance, including materials to help signpost

patients to appropriate sources of support is currently being developed and will be shared

with practices in advance of 1 December.

Thank you for your continued support in ensuring equitable access to health and social care

services in Northern Ireland.
