



## SERIOUS SHORTAGE PROTOCOL (SSP)

This SSP applies to the following medicine:

<b>Name of medicine (including strength and formulation)</b>	Nifedipine (Adipine <sup>®</sup> XL) 60mg modified-release tablet  <b><u>Pharmacists must ensure that the patient's prescriber and/or GP practice is notified when supplying a patient in accordance with this SSP. Pharmacists in Northern Ireland should note the specific guidance included in the addendum to this SSP.</u></b>

<b>Name of medicine (including formulation and strength) to be supplied</b>	Nifedipine (Adanif <sup>®</sup> XL) 60mg modified-release tablet  OR  Nifedipine (Coracten <sup>®</sup> XL) 60mg modified-release capsule  OR  Nifedipine (Coracten <sup>®</sup> XL) 30mg modified-release capsule
<b>Quantity of this formulation (if applicable)</b>	Total quantity supplied under this protocol to be equivalent to the original prescription.  For every Nifedipine (Adipine <sup>®</sup> XL) 60mg modified-release tablet, the following quantity must be supplied in

	<p>accordance with this protocol, noting that the second option is preferred over the third option:</p> <p>1 x Nifedipine (Adanif<sup>®</sup> XL) 60mg modified-release tablet</p> <p>OR</p> <p>1 x Nifedipine (Coracten<sup>®</sup> XL) 60mg modified-release capsule</p> <p>OR</p> <p>2 x Nifedipine (Coracten<sup>®</sup> XL) 30mg modified-release capsules</p>

### Clinical situation to which this Serious Shortage Protocol (SSP) applies

<b>Scope of SSP</b>	<p>All NHS and private prescriptions.</p> <p>This protocol does <b>not</b> allow for the quantity supplied to be less than the number of days prescribed on original prescription.</p>
<b>Criteria for inclusion</b>	<ul style="list-style-type: none"> <li>• The patient presents with a valid prescription (meeting the requirements of the Human Medicines Regulations 2012) for Nifedipine (Adipine<sup>®</sup> XL) 60mg modified-release tablets.</li> <li>• The patient/carer consents to receiving the medicine supplied under this SSP.</li> <li>• All patients aged 18 years of age or above.</li> </ul>
<b>Criteria for exclusion</b>	<ul style="list-style-type: none"> <li>• The patient presents with a prescription for a medicine other than Nifedipine (Adipine<sup>®</sup> XL) 60mg modified-release tablets.</li> <li>• The patient presents a prescription which is not valid.</li> </ul>

	<ul style="list-style-type: none"> <li>• The patient/carer does not consent to receiving the medicine(s) supplied under this SSP.</li> <li>• Where the pharmacist, using their professional judgement, determines that the patient is not suitable to receive alternative medicine under this SSP.</li> <li>• Patients aged less than 18 years.</li> </ul>
<b>Cautions including any relevant action to be taken</b>	<ul style="list-style-type: none"> <li>• Pharmacists should note that the order of substitutions reflects preferential use of regimen that most closely matches existing treatment, where available.</li> <li>• Pharmacists should counsel patients on a change in number of dose units to be taken if substituting with 2 x Nifedipine (Coracten® XL) 30mg modified-release capsules.</li> <li>• Ensure that patients considered unsuitable for inclusion are promptly referred back to their prescriber for management options.</li> <li>• Ensure that the patient's prescriber and/or GP practice is notified when supplying a patient in accordance with this SSP.</li> <li>• Ensure that patients who are supplied in accordance with this SSP are advised that they may require closer monitoring initially to ensure blood pressure/angina symptoms remain controlled, and to report any adverse effects.</li> </ul>
<b>Special considerations for specific populations of patients</b>	<p>Where the pharmacist, using their professional judgement, determines that the patient is not suitable to receive the alternative medicine in accordance with this SSP.</p> <p>Note: Nifedipine (Coracten® XL) modified-release capsules contain gelatin which may not be acceptable to some patients on cultural or religious grounds.</p>
<b>Action to be taken if the patient is excluded</b>	If a patient does not meet the criteria within this SSP they should be referred back to their prescriber promptly.
<b>Action to be taken if the patient or carer declines the supply</b>	If a patient/carer declines to receive medicine under this SSP they should be referred back to their prescriber promptly.

## 2. Conditions under which this Serious Shortage Protocol (SSP) will operate

- The decision to supply any medicine under this protocol rests with the individual registered pharmacist who must abide by the protocol.
- Whilst pharmacy staff may support the dispensing process of the protocol, this must be carried out under the supervision of the registered pharmacist.
- Pharmacists using this SSP must ensure that it is only used within its authorised dates and within the criteria set out within the SSP. Pharmacists must check that they are using the current version of the SSP, particularly when referring to a hard copy version. Amendments may become necessary prior to the published expiry date. ## **ADDENDUM**

### **Supporting information on notifying other healthcare professionals**

- Any items supplied in accordance with an SSP in response to an NHS prescription also needs to be supplied in accordance with NHS Pharmaceutical and Local Pharmaceutical Services Regulations.
- Those Regulations provide that where a therapeutic equivalent is supplied, a pharmacist will need to inform a patient's GP practice. This would generally be expected within the next working day, but further guidance would be given in any case where this applied.
- Where a different quantity, an alternative pharmaceutical form, an alternative strength or a generic equivalent is provided, it may not always be necessary that the patient's prescriber is informed, as the existence of the SSP may be enough for the prescriber to be aware that these changes in dispensing may take place, unless national arrangements agreed with the relevant representative bodies state otherwise. However, guidance may be issued on particular SSPs to indicate that prescribers should be informed of any patients that receive supply under it.
- In the absence of any preferred local alternate communication channels, all feedback to prescribers should be sent by NHSmail. The NHS Service Finder is a way for pharmacies to look up the email address of the patient's GP.

#### **Northern Ireland**

- Pharmacists must ensure that the patient's prescriber and/or GP practice is notified when supplying a patient in accordance with this SSP as soon as practically possible and should aim to forward these details within 3 working days.
