Notes:

The figures provided are the number of unique patients that received any prescription from the list of drugs provided during the financial year 2017/18. The same patients could have been receiving combinations of tablets/capsules or liquids within the year. Data can only be produced on age splits of patients where the prescription form has been scanned. Between 10-20% of all prescription forms in any given month cannot be scanned.

Due to this issue all figures provided are estimates only and will be an undercount of the true volume of units prescribed to patients aged under 17 in Northern Ireland. The patient count will be less likely to be impacted as it is a count of unique patients who received an anti-depressant at any point in the year so it only requires one form to have been scanned for the patient details to have been identified.

Not all prescription items will have been dispensed for depressive illness, drugs may be prescribed for other reasons such as neuropathic pain or obsessive compulsive disorder.

It should be noted that there are differences in prescription dispensing and processing in Northern Ireland compared to other UK regions and this should be noted if these statistics are to be used for comparative purposes to other parts of the UK.

For example in Northern Ireland there is no outpatient dispensing.

The Business Services Organisation (BSO) is the provider of the data. Prescription dispensing data is obtained from the BSO's prescribing and dispensing information systems. The data covers prescriptions that are prescribed in primary care and subsequently dispensed (by a Community Pharmacist, Appliance Supplier or Dispensing Doctor) and submitted to the Business Services Organisation (BSO) for payment. If a patient does not take a prescription to a dispenser and get it provided to them, then the information will not be included in the data.

I hope that the information provided assists you. If you are dissatisfied in any way with the handling of your request, you have the right to request a review. You should do this as soon as possible or in any case within two months of the date of issue of this letter.
